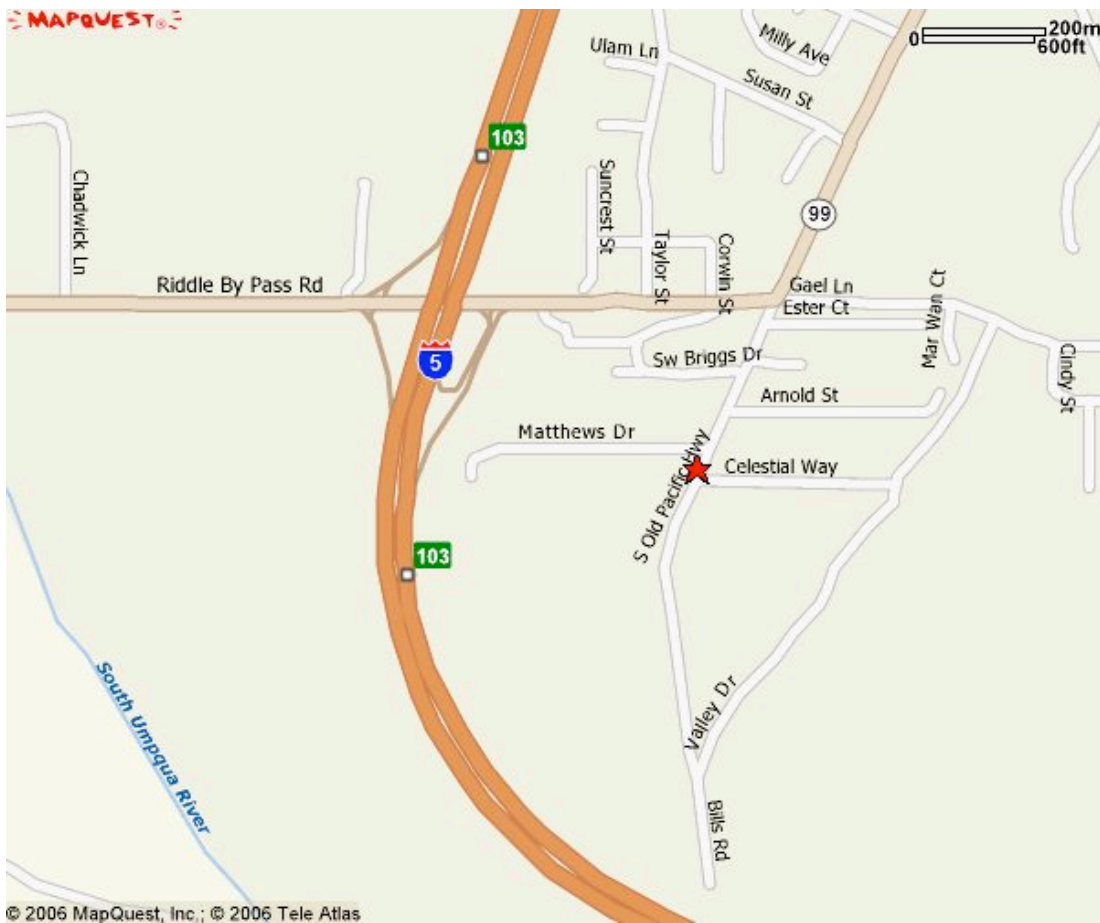

1. **TELECOMMUNICATION DEVICES ACCESS PROGRAM** (TDAP): The TDAP purchases and loans at no cost to eligible Oregonians special telecommunication devices to Oregonians who are deaf, hearing, speech and mobility (upper extremities) impaired. Download application at www.rspf.org

2. **OREGON TELEPHONE ASSISTANCE PROGRAM** (OTAP): Qualifying Oregonians whose income is at or below the current federal poverty level and are on a state public assistance program (Food stamps, Medical program at 135% federal poverty level or Supplemental Security Income) may receive a reduction in their monthly bill for local residential telephone service. 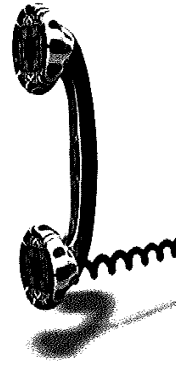
