*DSSO has some important information about Video Remote Interpreting, interpreting problems and Oregon Shakespeare Festival (OSF).*

Oregon Shakespeare Festival (OSF) is **quickly selling out** of all the tickets in the SI (Sign Interpreted) section for the interpreted performance of *To Kill a Mockingbird* on Sunday afternoon, May 29<sup>th</sup>. ## About Interpreting

Video Remote Interpreting (VRI) is not a replacement for live interpreters

in hospitals, law offices and other important places; VRI is used when there are no live interpreters. Also VRI helps protect patient/client privacy as some people do not feel comfortable with using local interpreters.

The Rogue Valley has a problem with live interpreters. There are not enough live interpreters in the Valley at all. So, VRI will help reduce the interpreter shortage.

Currently, Rogue Valley Medical Center (RVMC) has a VRI pilot (test) program in three areas: emergency room, registration and obstetrics (pregnancies). There are plans to expand VRI to other areas and to patient rooms.

There seems to be an interpreter problem at Providence - right now, there is no interpreting available. The problem is being investigated in house by Susan Hall. Please be aware that Ms. Hall is trying to help provide full communication access to deaf/hard of hearing patients and clients at Providence.

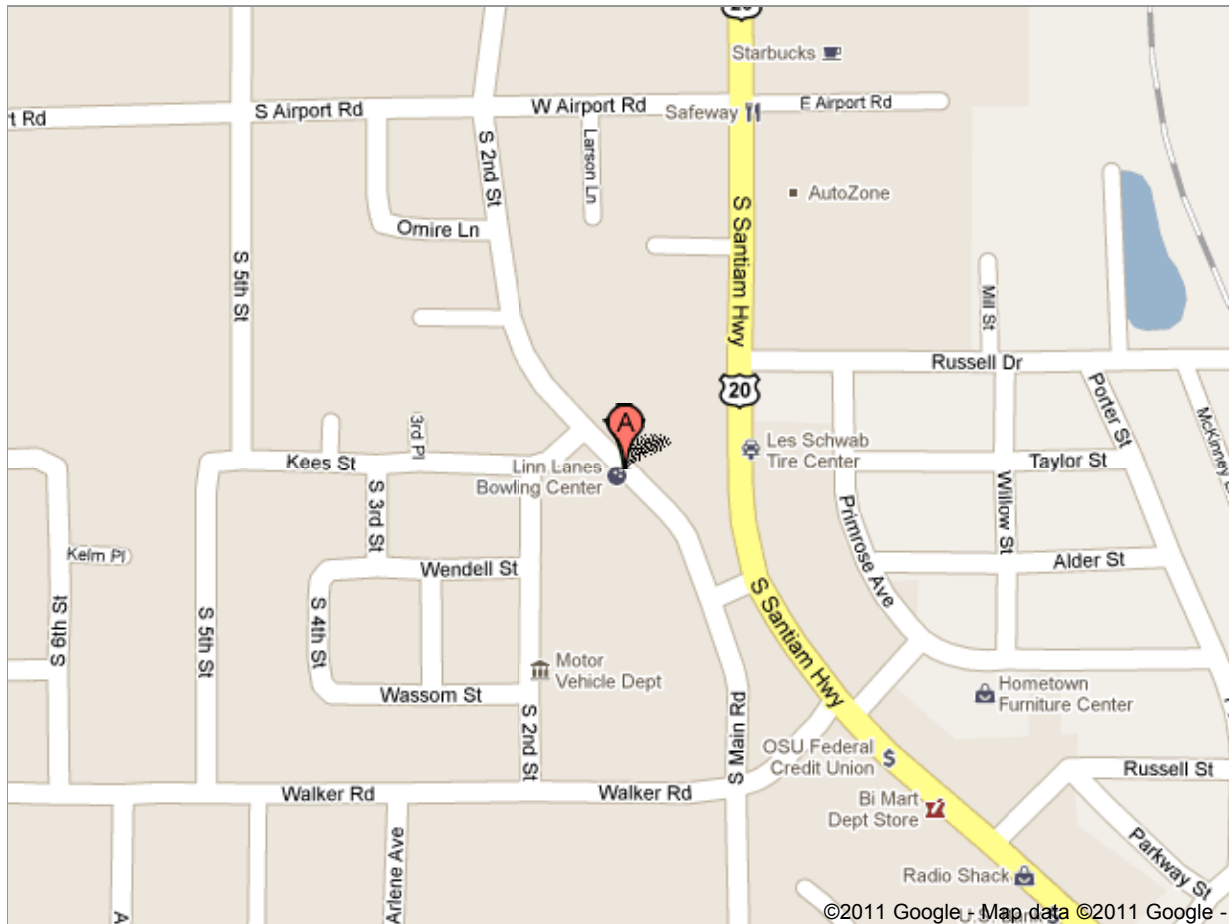

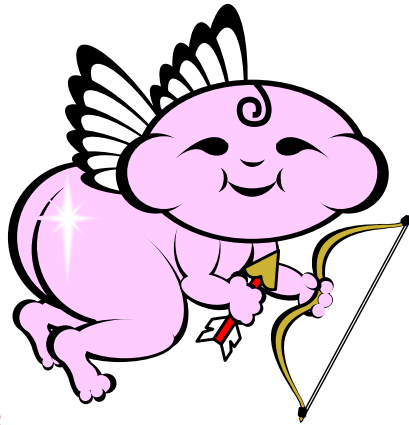
